    - iv. CPTED assessments for businesses
    - v. EC3 – activation project, potentially permanent trash receptacles

    - ii. Late August/Early Sept for the CPTED assessments – “Safety Week”
    - iii. Micro-grants: waiting on release of funds so currently delayed
    - iv. Community Activation projects – delayed, TBD
